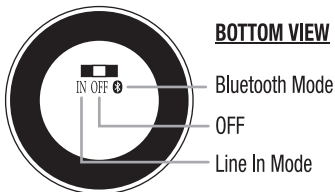
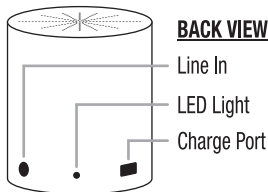


BLUETOOTH® WOODEN SPEAKER

INCLUDED: (1) Bluetooth Wooden Speaker, (1) Charging Cable, (1) Audio Cable

HOW TO CHARGE THE SPEAKER

Plug the supplied Charging Cable into the speaker's Charge Port. Connect the Charging Cable to a laptop USB port or AC wall adaptor (not included). The LED glows RED while charging. Once fully charged, the LED will turn off. Charging time is approximately 3-5 hours. *Please Note: It is recommended to fully charge the speaker prior to first use.*

PLAYING MUSIC

BLUETOOTH

To play music from a Bluetooth enabled device, switch to "Bluetooth" mode on the bottom of the speaker. Turn Bluetooth ON under "Settings" on the device (smartphone, tablet, etc.) you will be playing music from. When "ITW-105" appears on your device, select it to connect to the speaker. The LED Light will glow blue once your device and the speaker have paired successfully.

LINE IN

To play music from non-Bluetooth enabled devices, switch to "Line In" mode on the bottom of the speaker. Plug the supplied 3.5mm Audio Cable into the speaker's Audio Port. Connect the other end of the Audio Cable into the 3.5mm headphone jack of the device (smartphone, tablet, etc.) you will be playing music from.

CARE AND CAUTIONS

TROUBLESHOOTING

1. LED does not light when speaker is ON; recharge the speaker
2. Music playback is choppy or does not play in Bluetooth mode; device and speaker are too far away, move device within 33ft (10m) of speaker
3. Device and speaker are not pairing in Bluetooth mode; turn speaker OFF then back ON
